VETERANS NEWS by Carole Spiess

Each year the state American Legion Auxiliaries sponsor the Christmas Gift Shops at the Phoenix, Tucson, and Prescott VA hospital locations. The gift shops provide a large variety of new, purchased or donated, items which the veterans in the hospital or those doctoring at the hospital may select, free of charge, for their family members.

If you weren't at the luncheon, here are some highlights from our Christmas wrapping paper project for the Veterans Christmas Gift Shop. For the second year in a row, Pioneers provided a small mountain of gift wrapping supplies! 375 rolls of Christmas wrapping paper and countless bags of stick on bows, bags of To/From tags, packages of tissue wrapping paper, gift bags, rolls of Scotch tape were donated by Phoenix Thunderbird Club. Ninety-three volunteers (including at least two Pioneers) put in 500 hours helping 316 veterans shop for 503 family members. The volunteers at the eight wrapping stations at the Gift Shop, open December 3, 4, and 5, 2018, were going full tilt all day each day wrapping or stuffing into gift bags the hundreds of gifts selected by the veterans.

"Santa's Helpers" at the gift shop were very appreciative to Pioneers because they could use all donated money towards gift items. You who donated should be very proud of yourselves! This will be a yearly project for Pioneers. Thank you all, you are wonderful!

According to the Assistant Director of the VA Hospital, Phoenix VA Hospital is one of the largest in the United States. Because of our weather and schools that accept the GI Bill for schooling, we receive **200 to 300** new veteran patients each month. The hospital had intended to close the Mid-Town Clinic, 15th Avenue and Camelback, but decided to leave it open due to this increase.

A new clinic, OTC (Out Patient Clinic), will be opened soon at 32nd Street and Van Buren. It is a large building that will be completely remodeled. There will be two new floors added, the top two floors will house patients, there will be a cafeteria, and good news - it will have at least 1000 parking spaces! The VA is working to get Telecare for veteran patients and they are becoming a non-smoking facility.

The hospital received \$31 million for the updates. Last year they treated over a million veterans. A new parking garage will also be in the plans for the hospital and certain In-Patient clinics will be enlarged and others will relocate.

The VA Hospital is a teaching hospital with many students completing their training there and later hired by the VA. Students from the nearby medical school will train at the clinic and the VA Hospital. The hospital is getting rave reviews from the patients for their treatments, especially from the patients in Oncology and Veteran Long Term Care.

SCHOLARSHIP REQUIREMENTS

(Revised Dec 2018)

Purpose: To encourage qualified students within the state of Arizona to seek higher education beyond the secondary school level, and to provide financial assistance through the award of a \$1,000.00 scholarship in this state each year. The Phoenix-Thunderbird "Robert M DeBusk Memorial" Scholarships and Arizona Chapter 66 Scholarships are open to any student with an accompanying letter of recommendation from a Legacy West Pioneer.

SCHOLARSHIP APPLICATION

REQUIREMENTS FOR EACH APPLICANT

- 1. Any high school senior or current college student enrolled in an accredited college or university.
- 2. Definite choice of a liberal arts college, technical institute, teacher training college, specialized college school of nursing or junior college, provided that the institution offers a standard degree or certification course of study for no less than two years.
- 3. Acceptance by college or institute of choice.
- 4. Completion of this application, twice if applying for both scholarships.
- 5. Attach a copy of your latest school transcripts.
- 6. Interview with scholarship committee, if requested.
- 7. Positive need for scholarship.
- 8. On a separate paper, in 500 words or less, tell us about your community service or **volunteer activity** and the goals you have set for yourself.
- 9. At least one current letter of recommendation by a Legacy West Pioneer.
