## VETERANS NEWS by Carole Spiess (602) 242-1026

**At our** last meeting, the Associate Director caught us up on things happening at the hospital. At the current time, Phoenix has over 96,000 veterans registered at this VA hospital. By the end 2019 they expected another 40,000 veterans. This hospital rating has increased to one of the top ratings and is among the top 15 in the nation.

**Thanks** to fund raising and member donations, on December 10, on behalf of Phoenix Thunderbird Club, volunteer Carole Spiess presented a check to Michael Achey, Chief of Volunteer Services, for \$2500. The donation is specifically for the "9911 Fund" at the Phoenix VA hospital. The VA has a lengthy list of programs where donations may be designated – *i.e.* from Homeless Vets (9946 Fund) to Recreational Therapy (9957 Fund). The "9911 Fund" is considered a General Purpose Fund to be used to assist veterans in critical situations. As Carole has volunteered with Volunteer Services for over 27 years, she knows the "9911 Fund" money is not handed out lightly, so we know our funds will go directly to help a vet in serious need. *(See photo on website https://aztelecompioneers.org)* 

**December** 2, 3, and 4 was the Veterans' Gift Shop at the VA Hospital, in partnership with American Legion Auxiliary. Thanks to Pioneers money and material donations, we provided 103 rolls of wrapping paper plus countless packets of folded wrapping paper, 26 bags of bows, and rolls and rolls of Scotch tape. At least 255 veterans were able to select gifts, free of charge, for their family members (over 490) and themselves. Had Pioneers not been so generous with their donations, the wrapping items would have had to have been purchased which would have meant less money for purchasing the gifts.
